Mr. and Mrs. Brown are filing a joint return. Their taxable income on Form 1040, line 43, is \$25,300. First, they find the \$25,300 25,350 taxable income line. Next, they find the column for married filing jointly and read down the column. The amount shown where the taxable income line and filing status column meet is \$2,929. This is the tax amount they should enter on Form 1040, line 44.

CRA has changed the rules for 2012 tax year return eFiling. However our 2012 software was not built-in such feature. It only creates .tax file for your tax return and CRA has removed the web site for accepting the .tax file. Hence you have to mail the paper return to CRA for 2012 or previous tax year returns.
