A loan forgiveness period is a period of 12 consecutive months during which you have been employed or in practice and have provided in-person services for a minimum of 400 hours in an under-served rural or remote community. You must complete a full 12-month loan forgiveness period before applying.

Note: You can apply for Canada Student Loan forgiveness for family doctors and nurses if you are enrolled in full-time or part-time studies, are currently repaying your student loan, or are in your 6-month non-repayment period. If your Canada Student Loan is in repayment, you must continue to make your regular monthly payments.

[Public Service Loan Forgiveness | Federal Student Aid](#)
A qualifying loan for PSLF is any nondefaulted loan you received under the William D. Ford Federal Direct Loan (Direct Loan) Program. Only Direct Loans are eligible for PSLF. If you borrowed before July 1, 2010, some or all of your loans may have been made under an older federal

student loan program called the Federal Family Education Loan (FFEL) Program .

How to apply for the Public Service Loan Forgiveness program

Those seeking student loan forgiveness from the government's public service program can finally start the application process. After 10 years, the form was made available Friday.

Check Your Student Loan Forgiveness Eligibility

Unlike other student loan forgiveness programs, you apply for the Teacher Loan Forgiveness program after completing your five consecutive years of service and not before. So if you have already worked five qualifying years, you could apply and receive teacher loan forgiveness today using this application form .

student loan forgiveness programs - Federal Student Aid

The school signed your name on the application or promissory note without your authorization, or the school endorsed your loan check or signed your authorization for electronic funds transfer without your knowledge, unless the loan money was given to you or applied to charges that you owed to the school.

Student Loan Repayment Assistance & Forgiveness Options in ...

Student loans issued after August 1, 2000 and up until recently, have been issued by both provincial student loan programs and the National Student Loans Service Centre (NSLSC). These loans do not involve a bank or credit union but are issued and maintained by provincial or federal government appointed bodies.
